Draft Meeting Notes Governing Board Meeting November 27, 2018

Item 1 – Call to Order: The meeting was called to order by President Weintraub at 8:30 a.m. The meeting was held at Calabasas Library, Founders Hall Multipurpose Room.

Roll Call of Governing Board members present:

Alicia Weintraub, President Denis Weber, Vice President Laura Rosenthal Mark Rutherford Stuart Siegel

Item 2 – Approval of Agenda: There was a motion and second to approve the agenda. Motion carried unanimously.

Item 3 – Public Comment Period: None

Item 4 – Consent Calendar: 4.A Meeting Notes from October 16, 2018; 4.B October 2018 Executive Director's Report; and 4.C November 2018 Financial Statement. Terry Dipple highlighted his Executive Director's Report. Following his report, there was a motion and second to approve the items on the consent calendar. Motion carried unanimously.

Item 5.A and 5.B were discussed together: President Weintraub asked each Governing Board member to provide comments on their respective city's experiences during the Woolsey Fire. Laura Rosenthal reported that Malibu lost 450 homes in the fire and noted that Reva Feldman, City Manager, was not at the COG meeting because the city was attempting to reopen City Hall, following the fire. She said she appreciated SCE's efforts to restore power throughout the city. She thanked fire fighters and first responders. Stuart Siegel reported that Hidden Hills residents received a mandatory evacuation but the city did not lose any homes. He stated the community really stepped up to fight the fire that was adjacent to many homes and noted the city staff and councilmembers worked 24/7. Kerry Kallman, City Manager, expressed appreciation to Lt. Seetoo and Maria Grycan for their communications during the fire. Denis Weber reported Agoura Hills lost 9 homes and City Hall was evacuated. He stated staff worked 24/7. He noted the efforts of volunteers to evacuate horses and other animals and get them to safe locations. Mark Rutherford reported that the city received mandatory evacuation and Westlake Village lost 20 homes. City Hall was evacuated but staff continued to communicate and work with LA County Fire, Sheriff and Public Works. He felt the public safety agencies need to be able to back up a mandatory evacuation. He was also concerned about flooding in the area. Ray Taylor, City Manager, commented on MRCA not allowing Flood Control personnel onto their property to address the potential for flooding by citing CEQA issues. President Weintraub reported that Calabasas lost 9 homes. She stated the evacuation of the northern part of the city went well but the second

evacuation did not go well. She agreed that residents did not understand the term "mandatory evacuation" and residents complained of lack of fire deployment in the city. It was noted that there seemed to be a lack of coordinated communications by the various public safety agencies. She expressed concern as to how cities can support families who lost so much. Dr. Gary Lysik, City Manager, commented his role as the city spokesperson at incident command center and residents not following evacuation orders. He also cited conflicting reports on social media. Chief Anthony Whittle, LACFD, stated this was a historic fire and there were only 6 injuries to fire personnel. He noted wind gusts were 60-70 mph which compounded efforts to contain the fire. He said inaccurate and conflicting information on social media hurt firefighting efforts. Regarding the issue of mandatory evacuation, he responded that the fire department cannot make people leave the area. Lt. Jennifer Seetoo, LACSD, discussed issues related to public safety during the fire and problems the Sheriff's Department faced with enforcing mandatory evacuation. She also noted the department was working with LA County DPW staff to identify areas where there were potential flooding dangers. All of the Governing Board members and city managers expressed their appreciation to fire department and Sheriff's Department personnel for their efforts.

Senator Stern asked if each city would provide a comprehensive written report for him.

Rudy Gonzales, Southern California Edison, introduced the SCE personnel in attendance and the spoke of the concern and responsiveness of SCE prior to, during and after the fire. John Robinson, District Manager, SCE, discussed ICS training and stated SCE was about to energize an area with 500-1,000 homes and their crews have been working 24/7 in the area to address safety and power issues. Laura Rosenthal thanked SCE for their response during and after the fire.

President Weintraub announced this discussion would continue at the next COG meeting. Governing Board member Mark Rutherford stated this was his last meeting as he was retiring from the Westlake Village City Council. Governing Board member Stuart Siegel stated he should attend the January meeting to provide additional input from the city.

Item 6.A – Hazard Mitigation Plan: Terry Dipple announced that Cal OES revised its instructions to the COG and the Governing Board did not have to adopt the HMP prior to submitting it to Cal OES and FEMA for review and comment. He further stated that Cal OES and FEMA would be conducting a joint review of the HMP and would provide comments within 30 days. Therefore, no action was taken.

Item 6.B – Renewal of MOU with Metro for Professional Services for Metro Board Member and Extension of Maureen Micheline's Contract for one-year. There was a motion and second to approve the MOU and extend the contract. Motion carried unanimously.

Item 7.A – League of Cities: Jeff Kiernan provided an update from the League of Cities.

SUBJECT: Executive Director's Report

OVERVIEW

The purpose of this memorandum is to update the Governing Board on the status of COG projects and other items of interest.

Measure M Project List – The COG's Measure M 5-Year Project List will be on the January 2019 Metro Board agenda for approval. I worked closely with COG cities and Metro staff to address project eligibility issues. In the end, there continued to be eligibility issues that could not be resolved and the projects were left off of the COG's Measure M 5-Year Project List that Metro staff is recommending to the Board. This item is on the agenda for discussion and approval of the updated project list. Metro will be in attendance to address the eligibility issues. In addition, as I previously reported, the COG will receive \$12.5 million in our 6th year of Measure M: \$2.4 million for Active Transportation and \$10.07 million for Highways. If the Governing Board concurs, I will discuss funding and projects with the city managers at the TAC meeting and then the COG's Highway Working Group. I will report back as progress is made.

Stormwater – Recently, Los Angeles County, DPW sent out a letter to all of the cities in the County regarding nominating a city representative to serve on the Watershed Area Steering Committees. There are 9 Steering Committees in the County and the COG cities are in the North Santa Monica Bay Watershed Area Steering Committee, which has 7 seats: 2 for the LA County unincorporated area and Agoura Hills, Malibu and Westlake Village each have a designated seat. The remaining 2 seats will be self-appointed by 5 representatives from the County unincorporated area and Agoura Hills, Malibu and Westlake Village. Pursuant to the Measure W ordinance, a jurisdiction with at least 14% Impermeable Area located within the watershed area is guaranteed at least 1 seat while the remaining seats are decided collaboratively among the interested municipal representatives. I checked with LA County DPW and Calabasas and Hidden Hills do not have guaranteed seats. However, there are 2 seats remaining and each city could nominate a representative. Then, it would be up to the other 5 Steering Committee members to appoint the representatives. The initial meeting to select the municipal members will convene in mid to late January 2019 at Los Angeles County Public Works Headquarters, 900 South Fremont Avenue, Alhambra, CA 91803. The County is asking for the cities to confirm participation in the selection process by January 14, 2019. DPW staff has indicated the deadline is flexible. I would also point out that the representative should be a staff member that is familiar with technical stormwater and environmental issues.

I confirmed with Renee Purdy, Assistant Executive Officer, Regional Water Quality Board, that she will attend the February 19th COG meeting to participate in a "listening session" on stormwater issues. Initially, Madelyn Glickfeld, Board Chair, was supposed to attend, however, her term expired and she was not reappointed. Ms. Purdy indicated she would poll her board to determine which member(s) could attend. I have been working with COG city representatives to develop a list of discussion items. There was a slight delay due to the holidays, so I will have this at the COG meeting for approval before forwarding it to the Regional Board.

Hazard Mitigation Plan – Cal OES and FEMA completed their joint review of the COG's HMP and provided their comments. Those comments were forwarded to the consultant who will have revisions back to the COG on January 18, 2019. On January 8th and 9th I attended a 2-day training seminar that was put on by Cal OES, in Orange County. The training was geared toward grant applications, invoicing and general information.

Homeless Initiative — I attended the LA Family Housing Leadership Council meeting on November 28, 2018. You will recall that LA Family Housing The first meeting is on November 28th and discussion items include The COG's Homeless Working Group held its second meeting on October 25, 2018, to discuss the COG's homeless grant project and coordination issues. Malibu prepared a Guide to Addressing Homeless Encampments (trespassing and fires) for the COG cities. A copy is attached. The Working Group will continue to meet on a regular basis. COG cities are in two different LA County Service Planning Areas: Malibu is in SPA 5 and the other cities are in SPA 2. I attended a meeting with LA Family Housing and Meredith Berkson, LA County Homeless Team on November 14th to discuss resources. LA Family Housing is the LA County service provider for SPA 2, which includes Agoura Hills, Calabasas, Hidden Hills and Westlake Village.: Measure H Funding and Roles and Responsibilities.

Metro NextGen Bus System Study – Step One of the NextGen Bus Study has been completed. It includes the Market Demand and Travel Patterns Existing Service Evaluation. Metro learned how the public travels and how existing bus service relates to rider needs. Next, Metro will be reviewing service priorities to better meet the needs of the rider. I have asked Metro to present an update on the NextGen Bus Study at the February 2019 COG meeting.

Fact Sheet: Sales Tax Ballot Measure to Benefit Air Quality

<u>Summary</u>: This bill seeks authorization from the Legislature to allow a sales tax measure to be put on the ballot within the South Coast Air Quality Management District's (SCAQMD) jurisdiction, to clean the air, protect public health and reach attainment of federal air quality standards. This bill does not create a tax or a ballot measure directly, but instead allows either SCAQMD Governing Board action or a voter-driven initiative to put this proposal on the ballot.

<u>Benefits of Proposed Programs</u>: If approved by local voters, the tax will fund programs to assist in <u>eliminating</u> severe and unhealthy air pollution in Southern California and help:

- Greatly reduce serious health impacts, such as asthma, bronchitis, decreased lung growth in
 children, various cancer and cardiovascular risks, premature death, emergency room and hospital
 visits, and hundreds of thousands of estimated health-related lost work days and missed school days
 overall resulting in estimated monetized health benefits totaling tens of billions of dollars every
 year;
- Benefit disadvantaged communities disproportionately impacted by air pollution and toxics;
- Create co-benefit reductions in greenhouse gas emissions;
- Avoid federal sanctions that could: 1) cut off billions of dollars in federal highway funds; 2) create
 stricter requirements for businesses; and 3) result in the federal government taking over local air
 quality efforts which could result in draconian measures that could hurt the local economy; and
- Transform the goods movement industry and other industrial sectors to zero or near-zero emission, benefitting air quality, climate, toxic exposure and the economy.

Need for Bill:

- The 17 million residents in the South Coast breathe some of the most polluted air in the nation, with the highest levels of ozone and second-highest levels of particulate matter (PM).
 In 2017 the region exceeded the federal ozone standard for 145 days.
- Children, the elderly, and those with pre-existing conditions are particularly vulnerable and cannot avoid these pollutants.
- About 80% of regional nitrogen oxide (NOx) emissions are from mobile pollution sources, with most from trucks and heavy-duty equipment.

- Funding for cleaner vehicles and equipment is urgently needed to improve public health and meet upcoming federal clean air deadlines which require a 45% reduction of NOx emissions by 2023 and 55% by 2031.
- Significant additional emission reductions will be required by 2038 to meet the more stringent federal 2015 ozone standard.

<u>Note</u>: The tax rate has not yet been established, but for context, a ½ cent sales tax on \$10,000 in <u>taxable</u> items per year is about \$4/month. Non-taxable items include: rent, groceries, utilities, prescriptions, etc.

CONSIDER:

Α. APPROVING:

- 1. programming of \$22,045,893 in Measure M Multi-Year Subregional Program (MSP) Active Transportation/Transit/Tech Program (Attachment A);
- 2. programming of \$18,824,581 in Measure M MSP Highway Efficiency Program (Attachment B); and
- В. AUTHORIZING the CEO or his designee to negotiate and execute all necessary agreements for approved projects.

ISSUE

Measure M MSPs are included in the Measure M Expenditure Plan. All MSP funds are limited to capital projects. Each Subregion is required to develop the MSP five-year plan (Plan) and project list. Based on the amount provided in the Measure M Expenditure Plan, a total amount of \$57,888,134 was forecasted to be available for programming in Fiscal Year (FY) 2017-18 to FY 2021-22, to the Las Virgenes/Malibu Subregion in two Programs: 1) Active Transportation/Transit/Tech (expenditure line 56); and 2) Highway Efficiency (expenditure line 57). Board approval is necessary to program the funds to these projects and serve as the basis for Metro to enter into Funding Agreements with the respective implementing agencies.

DISCUSSION

On June 2017, the Metro Board of Directors approved the adoption of the Measure M Master Guidelines (Guidelines), with two amendments and five approved motions. Subsequently, the Administrative Procedures for Measure M MSP were signed by the Chief Executive Officer (CEO) on

The Las Virgenes/Malibu Subregion consists of the cities of Agoura Hills, Calabasas, Hidden Hills, Malibu, Westlake Village and adjacent unincorporated area of Los Angeles County. On May 31, 2018, a Funding Agreement was executed between Metro and the Subregion Council of Governments (COG) for the Planning Activities (Plan development and updates) for the MSP. The COG led the Plan development process, which includes working with all the member jurisdictions along with the public participation process. The COG Governing Board also adopted Subregional Qualitative Performance Measures including Mobility, Economic Vitality, Accessibility, Safety and Sustainability & Quality of Life, per the Administrative Procedures.

In the last several months, Metro staff worked closely with the COG and the implementing agencies on project eligibility reviews of the proposed projects. For those proposed projects that are to be programmed in FY 2018-19 and FY 2019-20 (near term - first two programming years), Metro required a detailed project scope of work during staff review for eligibility and program nexus during the Plan development process, i.e. project location and limits, length, project elements, project phase (s), total project expenses and funding requested, and project schedule, etc. The amount of details will ensure timeliness of the Project Funding Agreements execution once the Metro Board approves the Plan. For those proposed projects that will have programming funds in FY 2020-21 and beyond, Metro accepted high level (but focused and relevant) project scope of work during the review process. Metro staff will work with the Subregion and the implementing agencies on the details through a future annual update process. Those projects will receive conditional approval as part of this approval process. However, final approval of funds for those projects shall be contingent upon the implementing agency proving the eligibility of each project as required in the Guidelines.

Equity Platform

Consistent with Metro's Equity Platform, the MSP outreach effort recognizes and acknowledges the need to establish comprehensive, multiple forums to meaningfully engage the community to comment on the proposed projects under both Programs. COG along with the cities of Agoura Hills, Calabasas, Hidden Hills, Malibu, Westlake Village and adjacent unincorporated area of Los Angeles County undertook a robust outreach effort and invited the general public to a series of public workshops and meetings. Metro will continue to work with the Subregion to seek opportunities to reach out to a broader constituency of stakeholders.

DETERMINATION OF SAFETY IMPACT

Programming of Measure M MSP funds to the Las Virgenes-Malibu Subregional projects will not have any adverse safety impacts on Metro's employees or patrons.

FINANCIAL IMPACT

In Fiscal Year (FY) 2018-19, \$415,000 is budgeted in Cost Center 0441 (subsidies budget - Planning) for the Active Transportation/Transit/Tech Program (Project # 474401) and \$1.5 million is budgeted in Cost Center 0442 (Highway Subsidies) for the Highway Efficiency Program (Project #475503). Since

these are multi-year projects, Cost Centers 0441 (Planning - Subsidies to Others) and 0442 (Highway Subsidies) will be responsible for budgeting in future years.

Impact to Budget

The sources of funds for these projects are Measure M Transit, First/Last Mile (Capital) and Highway, Active Transportation, Complete Streets (Capital). These fund sources are not eligible for Metro bus and rail operating and capital expenditures.

IMPLEMENTATION OF STRATEGIC PLAN GOALS

Recommendation supports the following goals of the Metro Vision 2028 Strategic Plan:

Goal 1: Provide high-quality mobility options that enable people to spend less time traveling by alleviating the current operational deficiencies and improving mobility along the projects.

Goal 4: Transform LA County through regional collaboration by partnering with the Council of Governments and the local jurisdictions to identify the needed improvements and take the lead in development and implementation of their projects.

ALTERNATIVES CONSIDERED

The Board could elect not to approve the programming of funds for the Measure M MSP projects for the Las Virgenes/Malibu Subregion. This is not recommended as the proposed projects were developed by the Subregion in accordance with the Measure M Ordinance, Guidelines and the Administrative Procedures.

NEXT STEPS

Upon Board approval, respective implementing agencies will be notified, and Funding Agreements will be executed with those who have funds programmed in FY 2018-19 and FY 2019-20. Staff will continue to work with the Las Virgenes/Malibu Subregion COG and the implementing agencies to identify and implement projects. Annual updates will be provided to the Board.
