OVERVIEW

This report addresses the AB 361 (2021) findings that again must be made for the Governing Board to continue to be able to conduct teleconference meetings pursuant to special Brown Act requirements.

RECOMMENDATION

It is recommended that the Governing Board again make the AB 361 findings so that the COG will continue to have greater flexibility to conduct teleconference meetings during the COVID-19 state of emergency.

BACKGROUND

On March 4, 2020, Governor Newsom proclaimed a state of emergency to exist in California due to the spread of COVID-19. The Governor subsequently issued numerous executive orders suspending or modifying state laws to facilitate the response to the emergency. Among other things, these executive orders superseded certain Brown Act requirements and established special rules to give local public agencies greater flexibility to conduct teleconference meetings. The special rules included provisions allowing local public agencies to conduct teleconference meetings without having to provide a physical location from which the public may attend or comment, without having to use teleconference locations that are publicly accessible, and without having to identify teleconference locations on the agenda. Those special rules expired on September 30, 2021.

On September 16, 2021, in anticipation of the then-imminent expiration of his special rules for teleconference meetings, the Governor signed AB 361. In key part, this bill amended the Brown Act to establish special requirements for teleconference meetings if a legislative body of a local public agency makes two findings pursuant to Government Code Section 54953(e)(3). Like the special rules in the Governor's executive orders, the special Brown Act requirements in AB 361 include provisions allowing public agencies to conduct teleconference meetings without having to provide a physical location from which the public may attend or comment, without having to use teleconference locations that are publicly accessible, and without having to identify teleconference locations on the

agenda. The AB 361 special Brown Act requirements are scheduled be repealed on January 1, 2024.

In order for a local public agency to be subject to the AB 361 special Brown Act requirements for teleconference meetings, a legislative body of a local public agency first must make a finding that it has "reconsidered" the circumstances of a declared state of emergency. Second, the legislative body must find that such emergency continues to directly impact the ability of the legislative body's members to meet in person. Alternatively, for the second finding, the legislative body must find that state or local officials continue to impose or recommend social distancing measures. These findings must be made within 30 days after the legislative body teleconferences for the first time under AB 361 and every 30 days thereafter. The Governing Board last made these findings on November 2022.

FINDINGS

Governor Newsom is rolling back his COVID-19 Executive Orders in phases, but he has left his COVID-19 state of emergency declaration in effect. Furthermore, the State of California and the County of Los Angeles have recommended measures to promote social distancing. Thus, the California Division of Occupational Safety and Health still requires that employers provide training on the effectiveness of physical distancing in the workplace. Additionally, the Los Angeles County Department of Public Health continues to recommend that employers take steps to reduce indoor crowding and to enable employees and visitors to physically distance themselves from each other.

OVERVIEW

The purpose of this report is to update the Governing Board on the status of COG projects and other items of interest.

Homeless Count – The Los Angeles County Homeless Count is being held Tuesday, January 24, 2023, 6:00 PM – 10:00 PM, in Calabasas and Wednesday, January 25, 2023, 6:30 AM – 9:30 AM, in Malibu. Alicia, Gabriel and I have signed up as a team at the Calabasas location. Please let me know if you are interested in participating in the Homeless Count.

Supervisor Lindsey Horvath – Supervisor Horvath has agreed to participate in the COG's February 21, 2023 Governing Board meeting.

Senator Ben Allen – Senator Allen has agreed to participate in the COG's February 21, 2023 Governing Board meeting.

Assemblymember Jacqui Irwin – Assemblymember Irwin has agreed to participate in the COG's March 21, 2023 Governing Board meeting.

COG Highway Working Group – I continue to coordinate with Metro staff regarding the Measure R project list that was approved by the COG. It will be on the January 26, 2023 Metro Board agenda for approval. One other Measure R project will be scheduled for the February Board meeting along with the COG's Measure M project list, as previously approved by the Governing Board. In the next month or so, I call a meeting of the COG's Highway Working Group to discuss the Measure M 10th year allocation of \$13,574,070.

Metro Measure M Planning Funds – Metro provides the COG with funding for Measure M planning, which allows the COG to be reimbursed by Metro for my time spent on working with the cities on Measure M project planning. The allocation for the first five years was \$289,000. The funds are used by the COG to offset my contract. For example, the COG Budget includes \$55,000-60,000/year for the reimbursement. Metro recently amended our Funding Agreement to add the second 5-year allocation in the amount of \$326,021, which covers the current fiscal year through 26-27.

Sharing Cost of a Grant Writer with Las Virgenes Municipal Water District – Dave Pedersen reached out to me regarding the possibility of LVMWD and the COG contracting with a grant writing firm and sharing the cost. Madelyn Glickfeld, formerly of the LA Regional Water Quality Control Board and currently Co-chair of the North Santa Monica Bay Watershed Area Committee, has been monitoring grant opportunities (particularly water/stormwater related ones) for the North Santa Monica Bay Watershed. She has been exploring ideas to support the COG cities to take full advantage of grant opportunities that are available to us from various sources, including Measure W from the County of Los Angeles. The Governing Board may want to refer this to the TAC so the city managers can discuss the options and make a recommendation.

Homeless Grant Allocation – At the November 2022 COG meeting, the Governing Board approved an allocation of \$86,400 from the COG's Los Angeles County Homeless Grant funds to reserve the three beds at The People Concern shelter for unhoused individuals they are working with in Malibu. After discussing the matter with TPC, it was determined that the actual amount would be \$87,600. The COG expects to have the contract amendment finalized with the County by the end of the month.

Appoint Alternate Representative to the Santa Monica Bay Restoration Commission – Malibu Councilmember Steve Uhring is the COG current appointee to the SMBRC Governing Board. Mikke Pierson served as the COG's alternate representative and did not seek reelection to the Malibu City Council, last November. Traditionally, the COG appointee to the SMBRC has been a Malibu Councilmember. The COG is the authorized body to make the appointment.

In Person vs. Virtual Meetings – Effective March 1, 2023, most of the other LA County COGs are returning to in person meetings, with options for staff, board members and presenters to participate virtually.

California JPIA Outstanding Balance – I previously reported that the COG has a retrospective deposit liability of approximately \$33,000 with California Joint Powers Insurance Authority, which is a result of large claims against other agencies during the time the COG was a member. CJPIA was supposed to invoice the COG by year end and the city managers were planning to discuss repayment options. However, CJPIA has been delayed in obtaining some of the necessary data. I checked with them and they are working on the analysis and hope to have the final balance and invoices out within the next two weeks. I will report back after the city managers discuss the repayment options.

Local Agency Formation Commission Vacancy – The Local Agency Formation Commission for the County of Los Angeles (LAFCO) is conducting outreach to fill a Commission vacancy for an Alternate Public Member position. An application is available on the homepage of LAFCO's website (www.lalafco.org). The deadline to submit an application is 5:00 p.m. on Monday, March 13, 2023. HIGHLIGHTS FROM THE JANUARY 5th SCAG REGIONAL COUNCIL MEETING <u>ACTION</u> REGIONAL COUNCIL APPROVES TWO NEW PROGRAMS TO FUND LOCAL EQUITY

PLANNING

The Regional Council today approved two new programs that support local transportation and land use planning activities that provide direct benefit to under-resourced areas across the region.

The <u>Civic Engagement, Equity and Environmental Justice Call for Applications</u> will provide a total of \$5 million to support a wide range of eligible land use and transportation planning activities to close the racial equity gap. <u>This program</u> provides resources and direct technical assistance to local agencies and encourages co-applicant partnerships with community-based partners.

The Regional Council also approved the <u>2023 Go Human Community Hubs Program Guidelines</u> to provide resources to local community-based organizations to implement traffic safety strategies. SCAG anticipates opening the Call for Applications in February 2023 and will award approximately \$400,000 to organizations across the region.

ACTION REGIONAL COUNCIL APPROVES RELEASE OF AMENDMENTS FOR CONNECT SOCAL 2020 AND THE 2023 FEDERAL TRANSPORTATION IMPROVEMENT PROGRAM (FTIP)

In March 2022, SCAG staff began the development process for <u>Draft Connect SoCal 2020 Amendment</u> <u>#3</u> and <u>Draft 2023 FTIP Consistency Amendment</u>

<u>#23-03</u> in response to changes from the County Transportation Commissions (CTCs) and to proactively reduce impacts of the regional conformity lockdown. The Regional Council today authorized the release of both amendments and the transportation conformity analysis of both amendments for public review and comment from Jan. 6 to Feb. 5, 2023, at 5 p.m. A public hearing will be held on Jan. 17, at 10 a.m., for more information, <u>click here</u>.

Draft Connect SoCal 2020 Amendment #3 and 2023 FTIP Consistency Amendment #23-03 – Release for Public Review

Over the past several months, SCAG staff has worked in consultation and continuous communication with CTCs throughout the region to develop the Draft Connect SoCal 2020 Amendment #3 and 2023 FTIP Consistency Amendment #23-03. Modifications received from the CTCs are broadly categorized as new projects, existing projects that either have a revised description, revised schedule, and/or change in total cost, or projects removed from Connect SoCal 2020. Informed by these changes, SCAG staff has drafted content and assessed that these project modifications will not impact Connect SoCal 2020's ability to meet state and federal requirements.

Transportation Conformity Analysis of Draft Connect SoCal 2020 Amendment #3 and 2023 FTIP Amendment #23-03 – Release for Public Review

The transportation conformity analysis demonstrates that the Draft Connect SoCal 2020 Amendment #3

and 2023 FTIP Consistency Amendment #23-03 meet all federal transportation conformity requirements and is released as part of the Draft Amendments for public review.

TRANSPORTATION COMMITTEE

DRAFT DIGITAL ACTION PLAN RELEASED FOR 30-DAY PUBLIC REVIEW AND COMMENT

In February 2021, SCAG's Regional Council adopted a resolution pledging SCAG to assist in bridging the digital divide in underserved and unserved communities. Following approval at today's Transportation Committee, SCAG's Draft Digital Action Plan has been released for 30-day public review and comment from Jan. 5 to Feb. 3, 2023. After the comment period closes, staff will refine the language in the Digital Action Plan where applicable. The Final Digital Action Plan will be presented to the Transportation Committee and Regional Council on April 6, 2023, for approval and adoption. This item received broad support from the environmental and business communities and will go to the Regional Council in coming months.

SUBJECT: COG Priorities and Goals

OVERVIEW

The purpose of this report is to provide the Governing Board with background on the COG's priorities. Ongoing priorities include the following: Infrastructure Funding for Cities (Metro Measure M and R funding), Homelessness, Emergency Preparedness, Environmental (Stormwater and Watershed Management) and engaging area legislators to participate in COG meetings.

RECOMMENDATION

It is recommended that the Governing Board review the current priorities and provide direction to staff on any new priorities or goals.

BACKGROUND

The COG priorities, as set by the Governing Board, have resulted in the following major accomplishments:

- Approval of the COG's first regional Measure M Project: Regional Smart Cities Fiber Network (Phase One includes all of the COG cities, except Malibu)
- Retained a Homeless Outreach Coordinator
- Allocated almost \$200 million in Measure R (passed in 2008) and Measure M (passed in 2016) funds to COG cities for various infrastructure improvements, including highways, pedestrian safety, bridge improvements and green streets projects.
- Prepared the COG's Hazard Mitigation Plan (which covered all five cities) and subsequent updates every five years. All completed with FEMA grant funding.
- Prepared Watershed Area Management Plan
- Endorsed Measure W, the Safe Clean Water initiative that was approved by LA County voters, which generates funding that is allocated for local and regional stormwater projects.
- Area legislators regular participation in COG meetings.
