SUBJECT: AB 361 Findings to Continue Teleconference Meetings

OVERVIEW

This report addresses the AB 361 (2021) findings that again must be made for the Governing Board to continue to be able to conduct teleconference meetings pursuant to special Brown Act requirements.

RECOMMENDATION

It is recommended that the Governing Board again make the AB 361 findings so that the COG will continue to have greater flexibility to conduct teleconference meetings during the COVID-19 state of emergency.

BACKGROUND

On March 4, 2020, Governor Newsom proclaimed a state of emergency to exist in California due to the spread of COVID-19. The Governor subsequently issued numerous executive orders suspending or modifying state laws to facilitate the response to the emergency. Among other things, these executive orders superseded certain Brown Act requirements and established special rules to give local public agencies greater flexibility to conduct teleconference meetings. The special rules included provisions allowing local public agencies to conduct teleconference meetings without having to provide a physical location from which the public may attend or comment, without having to use teleconference locations that are publicly accessible, and without having to identify teleconference locations on the agenda. Those special rules expired on September 30, 2021.

On September 16, 2021, in anticipation of the then-imminent expiration of his special rules for teleconference meetings, the Governor signed AB 361. In key part, this bill amended the Brown Act to establish special requirements for teleconference meetings if a legislative body of a local public agency makes two findings pursuant to Government Code Section 54953(e)(3). Like the special rules in the Governor's executive orders, the special Brown Act requirements in AB 361 include provisions allowing public agencies to conduct teleconference meetings without having to provide a physical location from which the public may attend or comment, without having to use teleconference locations that are publicly accessible, and without having to identify teleconference locations on the

agenda. The AB 361 special Brown Act requirements are scheduled be repealed on January 1, 2024.

In order for a local public agency to be subject to the AB 361 special Brown Act requirements for teleconference meetings, a legislative body of a local public agency first must make a finding that it has "reconsidered" the circumstances of a declared state of emergency. Second, the legislative body must find that such emergency continues to directly impact the ability of the legislative body's members to meet in person. Alternatively, for the second finding, the legislative body must find that state or local officials continue to impose or recommend social distancing measures. These findings must be made within 30 days after the legislative body teleconferences for the first time under AB 361 and every 30 days thereafter. The Governing Board last made these findings on July 13, 2022.

FINDINGS

Governor Newsom is rolling back his COVID-19 Executive Orders in phases, but he has left his COVID-19 state of emergency declaration in effect. Furthermore, the State of California and the County of Los Angeles have recommended measures to promote social distancing. Thus, the California Division of Occupational Safety and Health still requires that employers provide training on the effectiveness of physical distancing in the workplace. Additionally, the Los Angeles County Department of Public Health continues to recommend that employers take steps to reduce indoor crowding and to enable employees and visitors to physically distance themselves from each other.

OVERVIEW

The purpose of this report is to update the Governing Board on the status of COG projects and other items of interest.

COG Highway Working Group – I continue to coordinate with Metro staff regarding the \$15 million Measure R project list that was approved by the COG. It will likely go to the Metro Board for approval in January or February 2023.

COG Homeless Grant Funding and Recommendations – Recently, the County CEO staff held meetings with the COG to discuss programming additional grant funds. The COG's Homeless Working Group will meet on Monday, November 14, 2022 to discuss and make a recommendation to the Governing Board.

Measure M/R Projects – I am continuing to work with Metro and COG cities to move our projects forward. Additional meetings are being arranged to address eligibility issues. I will provide updates as soon as possible. Our project list is tentatively set for the January 2023 Metro Board meeting.

California JPIA Outstanding Balance – As reported, last month, the COG has a retrospective deposit liability in the amount of \$33,505 with CJPIA, which is a result of large claims against other agencies during the time the COG was a member of CJPIA. The city managers will be discussing payment options at the January 2023 TAC meeting and I will report their recommendation to the Governing Board at the January COG meeting.

COG Executive Directors Monthly Check-In with Metro CEO Stephanie Wiggins – Regular monthly meeting with LA County COG executive directors and the CEO are proving to be very productive.

Metro Project Updates – I continue to meet regularly with Metro Highway and Active Transportation staff to discuss the status of COG projects.

COG's Homeless Outreach Coordinator – Gabriel continues to provide weekly updates on his assistance to people experiencing homelessness in the region.

HIGHLIGHTS FROM THE NOVEMBER 3rd SCAG REGIONAL COUNCIL MEETING ACTION

REGIONAL EARLY ACTION PLANNING (REAP) 2.0 COUNTY TRANSPORTATION COMMISSION (CTC) GUIDELINES AND CALL FOR PROJECTS & PROGRAMS TO ACCELERATE TRANSFORMATIVE HOUSING (PATH) PROGRAM APPROVED

The Regional Council approved and adopted the <u>REAP 2.0 CTC Guidelines</u> and CTC Partnership Program Call for Projects, as well as the <u>REAP 2.0 PATH Program</u>.

REAP 2.0 CTC Guidelines and Call for Projects

SCAG developed guidelines for the CTC Partnership Program, funded by REAP 2.0. The Regional Council approved the guidelines, which were open for a three-week public comment period, from Sept. 21 to Oct. 12, 2022. The Regional Council also approved opening the CTC Call for Projects in early 2023, pending final approval from the California Department of Housing and Community Development on SCAG's REAP 2.0 application. The CTC Partnership Program will provide immediate benefit to the region by supporting transformative planning activities aligned with key connection strategies identified in Connect SoCal, which will be implemented quickly to advance new concepts for reducing vehicle miles traveled, while simultaneously achieving other program goals for REAP 2.0. The final CTC Program will be updated to reflect any feedback received once SCAG's full REAP 2.0 funding application is approved by the State.

REAP 2021 PATH Program

The Regional Council approved the PATH Program and authorized its implementation. The PATH program, which was formerly named the Housing Supportive Infrastructure Program, is one of the three major funding areas in SCAG's REAP 2.0 Program Development Framework. The program guidelines outline the program's components, requirements, eligible applicants and actions, and application process, as well as, the staff recommendation that \$88.835 million of SCAG's REAP 2.0 funding be set-aside to support the program. The PATH program supports actions that accelerate infill development that facilitates housing supply, choice, and affordability; affirmatively furthers fair housing; and reduces vehicle miles traveled through a Notice of Funding Available and two pilot programs designed to bring housing production to scale across the Southern California region to meet the 6th Cycle Regional Housing Needs Allocation.

REGIONAL COUNCIL APPROVES PROJECTS SEEKING TRADE CORRIDOR ENHANCEMENT PROGRAM (TCEP) FUNDING AND APPLICATION COORDINATION

SCAG's Regional Council approved the recommended regional TCEP project nominations and authorized staff to proceed with a TCEP grant application in coordination with Caltrans and TravelCenters America.

TCEP is a grant program created to fund infrastructure improvements on federally designated trade corridors on California's portion of the National Highway Freight Mobility Plan. SCAG, as the region's metropolitan planning organization, is tasked with compiling project nominations from its respective agencies to send to the California Transportation Commission.

Multiple agencies across the SCAG region have nominated <u>16 projects</u> for TCEP consideration. Additionally, SCAG will partner on a Caltrans-led TravelCenters of America TCEP application. The TravelCenters of America project is seeking to deploy microgrid-enabled, electric charging equipment for heavy-duty trucks at existing TravelCenters of America and Petro travel centers in the region.

INFORMATION 2022 RACIAL EQUITY BASELINE CONDITIONS REPORT RELEASED

The 2022 Racial Equity Baseline Conditions Report was released. In July 2020, SCAG's Regional Council adopted a resolution affirming its commitment to advancing justice, equity, diversity, and inclusion throughout Southern California and subsequently adopted the Racial Equity Early Action Plan (EAP) in May 2021, outlining goals, strategies and actions to advance equity. The EAP included a Racial Equity Baseline Conditions Report that highlighted past transportation and housing policies and provided a preliminary baseline assessment of racial equity in the region. The newly released version of this report is updated to include 2020 data, new equity indicators, and county narratives. NEWS FROM THE PRESIDENT GO HUMAN MINI-GRANT REPORT

President Harnik gave an update on the SCAG <u>Go Human</u> Mini-Grants Program, which concluded in September 2022. The program funds community-based organizations, non-profits and social enterprises to implement innovative traffic safety and community engagement projects. SCAG awarded over \$350,000 to 26 projects representing all six counties in the region. Projects included demonstrations of safety infrastructure, public art to encourage safe driving, walk audits, community bike rides and other outreach events.

NEWS FROM THE EXECUTIVE DIRECTOR CONNECT SOCAL PROGRAM ENVIRONMENTAL IMPACT REPORT (PEIR) NOTICE OF PREPARATION (NOP)

SCAG released a Notice of Preparation (NOP) of a Draft Program Environmental Impact Report (PEIR) for Connect SoCal 2024. Release of the NOP formally kicks off the environmental review process, in accordance with the California Environment Quality Act, for the upcoming Connect SoCal 2024. The NOP is under the required 30-day public review and comment period from Oct. 17, to Nov. 16, 2022. Additionally, SCAG is hosting two virtual public scoping meetings for the NOP on Wednesday, Nov. 9, from 6 to 8 p.m., and Thursday, Nov. 10, from 10 a.m. to noon. HOUSING-SUPPORTIVE GRANT UPDATES: CHANGE TO NOTICE OF FUNDING AVAILABILITY AND TECHNICAL ASSISTANCE FOR APPLICATIONS

The deadline for all SCAG jurisdictions to have compliant housing elements was Oct. 15. Non-compliance triggers a number of impacts, including potential ineligibility for critical funding resources. Staff will

continue to monitor funding sources and requirements to advocate on behalf of the cities and counties in our region to ensure residents have the greatest access to funding resources.

On Oct. 7, the California Department of Housing and Community Development (HCD) issued an amendment to the Permanent Local Housing Allocation (PLHA) guidelines that extended the application deadline to Nov. 30 and clarified that jurisdictions without compliant housing elements may apply if their housing element is compliant by the date of the funding award. HCD plans to award PLHA funds by February 2023.

SCAG will be offering PLHA application assistance, as well as technical assistance for jurisdictions and Tribal Governments to prepare and submit applications for other housing-supportive funding. HCD and other public agencies are releasing several notices of funding availability for grants. SCAG is offering expert assistance on a rolling basis to help selected recipients prepare and submit applications for these funds and grants. RECAP OF REGIONAL ADVANCE MITIGATION PLANNING (RAMP)/SOCAL GREENPRINT WORKSHOP

In October, SCAG held a virtual workshop for public stakeholders to share an update and gather input on the <u>Draft Regional Advance Mitigation Planning (RAMP) Policy Framework</u> and the process for developing the <u>SoCal Greenprint</u> tool. SUBJECT: COG's Homeless Grant Funds

OVERVIEW

The purpose of this report is to provide the Governing Board with information on the COG's Homeless Grant Funds from Los Angeles County.

RECOMMENDATION

That the Governing Board allocate \$86,400 in Innovation Grant Funds for three beds at The People Concern shelter and a similar amount for beds at Hope of the Valley's shelter.

BACKGROUND

The COG's 22/23 Contract/Statement of Work with Los Angeles County provides the COG will use the grant funding to manage the tasks, including coordinating with cities to participate in interjurisdictional activities and meetings and facilitating a regional approach to prevent and combat homelessness in the County. The maximum contract amount is not to exceed \$375,000. Up to \$90,000 of the total contract budget is to be paid by County for the COG's Regional Homelessness Coordination costs (Gabriel Graham, Outreach Coordinator \$72,000 and Jessica Flores, administrative support \$12,000).

Up to \$285,000 of the total contract budget is to be paid by County for LVMCOG Innovation costs. These funds must be used to support their member cities to implement activities that align with the approved Homeless Initiative Action Plan to Prevent and Combat Homelessness. These tasks are to be separate from and not duplicative of work funded for Regional Homelessness Coordination.

Malibu has been considering allocating \$86,400 in city funds to reserve three beds at The People Concern shelter. I raised the issue with the County if we could use Innovation grant funds, instead of Malibu using city funds to reserve the beds. The County agreed. I will be recommending to the COG's Homeless Working Group at the meeting on November 14th that the COG use \$86,400 in Innovation Funds to reserve the three beds at The People Concern shelter. In addition, I have asked Gabriel to check with Hope of the Valley to see if the COG can reserve beds there for the cities in SPA 2. I will provide an update at the November 15, 2022 COG meeting.
