Rob asked about Malibu purchasing food. They bought basics for 5,000 people, stocked up on paper goods, sisco and home depot pro, HH bought a pallet of food, AH did as well and should arrive tomorrow, Gary said Calabasas has some cache units throughout the city

Jeff Kiernan asked if any food distributed, hasn't happened yet.

Chuck said station is fully staffed. Sheriff has begun a contingency plan for 8-12 weeks, a matter of time until Sheriff goes to 12 on 12 staffing, Sheriff has made Malibu beach parking lots a priority, not seeing a rise in family disturbance calls,

Gary asked about Sheriffs contracting COVID-19, a deputy's relative contracted it

Chief Brown no alternate work plan yet, in contact with DPW re storms, asked cities to monitor problematic issues with mud, flooding, etc.

Rob said they were contracted by a private company about doing mobile testing,

Chief Brown said everything with FD is going through DPH
