SUBJECT: Executive Director's Project Update

OVERVIEW

The purpose of this report is to update the Governing Board on the status of COG projects and other items of interest.

During the month of August and early September most of my time was spent focusing on the update of the COG's Hazard Mitigation Plan, Measure M funding discussions with the cities, Metro and Magellan and addressing funding issues for the COG's homeless grant funding.

Hazard Mitigation Plan – The COG's HMP Working Group held another meeting with the consultant on August 14 with all city representatives participating. The consultant provided an update for the city managers at the September TAC meeting. The consultant is in the process of scheduling the public workshops in the COG cities. More information will be provided once the public meetings are scheduled. I will continue to provide updates to the Governing Board and TAC as the process moves forward and will schedule a presentation by the consultant for the November COG meeting. It is anticipated the HMP update will be submitted to Cal OES by the end of the year. Thereafter, the consultant will review any comments from Cal OES with the HMP Working Group, and make any revisions, as needed. The final HMP will then be resubmitted to Cal OES, who will review and forward it to FEMA for final approval.

Measure M Projects – The COG city reps joined my monthly check-in meeting with Metro to review ongoing city projects. Metro Highway and Active Transportation staff went through each city's projects and discussed any needed follow up.

Regional Smart Cities Fiber Network Project – The COG held a kickoff meeting with city staff representatives on September 12 where the Magellan team outlined the process for design engineering and what the cities could expect. Jory Wolf, Magellan, will be at the September COG meeting to provide an overview and answer questions.

Metro – I held a meeting with Ara Najarian's new Metro Board Deputy, Vivian Rescalvo, to go over existing city projects, the COG's fiber project and general Measure M funding issues.

Calabasas Communications and Technology Commission – I will be participating in the September meeting of the Calabasas Communications and Technology Commission to discuss the COG's Regional Smart Cities Fiber Network. The meeting is September 19, 2023, 6:00 PM.

Grant Research – The one-time \$1,500 shared effort with Las Virgenes Municipal Water District did not turn up any real grant opportunities. California Consulting provided 12 grants with a focus on stormwater, planning and project grants. Dave Pedersen and I discussed the outcome and determined it would be best to pursue other options.

COG Homeless Working Group – The COG's Homeless Working Group will be holding its regular meeting on September 25. City, County, Sheriff, DMH, HOST and other agencies participate in the meeting.

Highlights from the September 7, 2023 SCAG Regional Council Meeting

ACTION: Updates on Connect SoCal 2024 & Stakeholder Engagement

This month, SCAG's Joint Policy Committee recommended the draft Connect SoCal 2024 Plan to the Regional Council for approval to release for circulation in November. The committee heard a presentation previewing the contents of the Plan, which showcased key policies and strategies to be included in the draft Plan to address existing and emerging challenges facing the region. The presentation also showed how the Plan is based on the best available information, and rooted in local planning and policy actions.

In anticipation of the draft Plan release, SCAG staff continue to engage key stakeholders and provide standing updates at SCAG's policy committees and working groups. Further discussions, along with other necessary engagement and consultation with tribal governments, elected official briefings and public hearings, will occur during the public review period.

Following the public review and comment period, including a concurrent review and comment period for the program environmental impact report, the final Connect SoCal Plan is expected to be put forward for approval in April 2024. ACTION: Regional Council Approves RHNA Reform Recommendations

In September, the <u>Regional Council approved the release of SCAG's recommendations</u> on the reformation of the <u>Regional Housing Needs Assessment (RHNA) process</u>. These recommendations will be provided to the California Department of Housing and Community Development (HCD) in a formal letter to be included in a report of recommendations to the California State Legislature.

On Aug. 16, SCAG staff presented a total of thirteen recommendations at a special meeting of the Community, Economic and Human Development Committee, with changes to the regional determination, methodology and appeals processes. The committee acted to recommend the draft recommendations be moved to the Regional Council for further action.

Some recommendations will also require legislation to implement changes while others will be evaluated as part of the 7th RHNA cycle. The Legislative/Communications & Membership Committee will now use the recommendations to prepare multiple proposals for potential SCAG-sponsored bills and to advocate for bills containing high-

priority RHNA reform concepts. SCAG will continue to monitor and report on HCD's process and explore ways to implement the approved recommendations. As part of its statewide RHNA reform effort, HCD is soliciting comments until Sept. 15. For more information on SCAG's RHNA program, visit scag.ca.gov/rhna.

ACTION: Regional Council Approves Updates to PATH Guidelines, RUSH Call for Applications

At its September meeting, the Regional Council approved updates to the Programs to Accelerate Transformative Housing (PATH) guidelines, setting up the release of the Regional Utilities Supporting Housing (RUSH) Pilot Program Call for Applications this fall. This represents \$35 million from the Regional Early Action Plan (REAP) 2.0 Program that will be focused on funding utility infrastructure planning and shovel-ready capital improvements that will help meet housing production goals. These updates incorporate input from the RUSH forum earlier this year and are part of ongoing work to distribute the \$237 million awarded to SCAG from the California Department of Housing & Community Development for the REAP 2.0 Program. SCAG staff continue work to launch funding programs focused on accelerating infill development, connecting infill housing to daily services and increasing travel options, and building capacity for planning innovation through data-driven decision-making tools. Demographic Workshop Program Now Available

Regional Early Action Planning 2.0 Update

In July, the HCD approved SCAG's full REAP 2.0 application, formally awarding \$246 million to the SCAG region. SCAG has issued Calls for Applications for five programs to sub-allocate a significant portion of the REAP 2.0 funds to eligible entities in the SCAG region. In July, the Regional Council approved the projects for the County Transportation Commission Partnership Program. The Regional Council will consider the approval of awards for the Sustainable Communities Program, Housing Infill on Public and Private Lands Pilot Program and Notice of Funds Available for Lasting Affordability this fall. SCAG Clean Cities Redesignation

SCAG Leadership met remotely last month with leadership from the Department of Energy's Clean Cities Coalition redesignation committee. SCAG Regional Council Second Vice President Cindy Allen, Immediate Past President Jan Harnik and Regional Council member Oscar Ortiz attended and shared their support for the program along with members of the SCAG Executive team who shared the importance of this work, as well as the California regulatory drivers and the need for more funding in this area. SCAG staff provided a detailed presentation outlining SCAG's coalition structure, recent accomplishments, and activities and future work plan, highlighting the Passenger Electric Vehicle Atlas, the Zero Emission Truck Infrastructure Study and the Last Mile Freight Program. Stakeholder outreach and engagement were also demonstrated by participation from Clean Cities Coalition collaborators. A formal letter of redesignation is forthcoming. Greenprint Technical Advisory Committee Second Meeting

SCAG held the second meeting of the SoCal Greenprint Technical Advisory Committee on Aug. 28. The meeting included a discussion of potential draft data standards for identifying, evaluating and selecting data. This work supports the TAC's purpose of ensuring the future SoCal Greenprint tool is aligned with policy objectives identified in the approved Regional Advanced Mitigation Planning policy framework. The final TAC meeting is scheduled for Sept. 25 and will include discussions on revisions to the draft data standards, tool functionality and beta testing. After this final meeting, SCAG will continue to integrate committee input into staff recommendations for further development of the Greenprint tool, which will be brought to the Energy and Environment Committee in November for consideration.

CONNECT SOCAL OUTREACH WRAPS UP

SCAG has concluded the in-person and virtual workshops for Connect SoCal held throughout the region in April and May 2023. These workshops invited stakeholders to share thoughts on pressing issues impacting Southern California. Stakeholders can still contribute to Connect SoCal by <u>taking a brief survey before June 4</u>.

SCAG will present highlights and findings from the Connect SoCal outreach to the Regional Council in July and ask the Executive/Administration Committee and Regional Council to approve an update to the Connect SoCal Policy Development Framework based on feedback received at the May Policy Committee meetings.

UPDATE ON REGIONAL HOUSING NEEDS ASSESSMENT PROCESS

The California Department of Housing and Community Development is crafting recommendations to reform the Regional Housing Needs Assessment (RHNA) process, which will be provided in a report to the California State Legislature by Dec. 31.

SCAG is seeking input from jurisdictions, stakeholders and the public on our own <u>draft RHNA reform</u> recommendations through a <u>brief public survey</u>. In addition to the survey, we will hold public listening sessions on June 22 and June 27. Stakeholders can also submit comments at housing@scag.ca.gov.

UPDATE ON THE SOCAL GREENPRINT TECHNICAL ADVISORY COMMITTEE

SoCal Greenprint will be an optional and open data and mapping tool for the SCAG region to support regional advanced mitigation planning. Regional advanced mitigation planning (RAMP) is a process to expedite project delivery by planning for environmental mitigation to reduce environmental impacts earlier in the planning process and at a wider scale. SCAG is in the process of finalizing the SoCal Greenprint Technical Advisory Committee (TAC), which will advise on the development of the Greenprint tool and ensure its alignment with the approved RAMP policy framework.

The TAC will be a forum for potential users to provide direct feedback on data selection and policies to ensure SoCal Greenprint is an effective tool for users throughout the region.

SCAG is currently reviewing applications and working to fill gaps to ensure regional representation. Once membership is finalized, SCAG will schedule meetings with the TAC in summer 2023.

SCAG will report on recommendations for the Greenprint tool at the Energy and Environment Committee and Regional Council in fall 2023. Development will include beta testing with potential users and stakeholders. SCAG anticipates the development of the SoCal Greenprint to be completed in spring 2024.

SCAG HOSTS LISTENING SESSION WITH THE CALIFORNIA STATE TRANSPORTATION AGENCY

SCAG hosted California Secretary of Transportation Toks Omishakin on May 8 for a listening session with transit agencies from throughout Southern California to hear about regional financial and regulatory challenges and solutions in this post-pandemic era. The conversations at the session centered around the economy, workforce development, transition to zero emissions, more transit funding and housing.

SCAG continues to support our region's transit operators through legislative advocacy, technical assistance, and regional engagement.

SUBJECT: Annual Measure M Allocations and Project List

OVERVIEW

The purpose of this report is to provide the Governing Board with project funding recommendations for the proposed Annual Measure M Project List.

RECOMMENDATION

The recommendation has been changed since the September 2023 Technical Advisory Committee meeting. However, the city managers have been briefed on the changes and continue to support the recommendation that the Governing Board approve the annual Measure M allocations and project list detailed below.

BACKGROUND

In October 2022 the TAC and Governing Board approved the COG's annual 9th Year Measure M Project List for 25/26. The 9th year allocation from Metro was \$13,231,377 of which \$9,044,676 was designated for the COG's Regional Smart Cities Fiber Network. Prior to the February 2023 Metro Board meeting, the COG was informed by Metro staff that it would only be approving \$300,000 for design engineering, which is currently underway. Metro staff indicated the Board would approve the remainder after the design engineering was completed.

The 9th Year (25/26) allocations for the Regional Smart Cities Fiber Network that were approved by the COG but not approved by the Metro Board:

Agoura Hills	1,000,000
Calabasas	3,625,397
Hidden Hills	277,859
Westlake Village	1,309,906

9th Year (25/26) projects approved by the Metro Board include the following:

- Agoura Hills' Kanan/Agoura Intersection Project \$2,200,000
- Malibu's PCH Pedestrian Signal \$325,000

Malibu's Pedestrian Undercrossing \$1,659,706

At the September TAC meeting, I presented the option to the city managers to allocate \$5 million of the \$8,744,676 unallocated 9th Year (25/26) funds to the Regional Smart Cities Fiber Network and allocate the remaining \$3,744,676 for on-going city projects. I subsequently spoke with Metro about the allocations and Metro suggested that the COG program the 9th year funds in September 2024. This will give the cities additional time without delaying any project or funding. In other words, instead of programming funds 2-3 years out, it would be approved by the COG, in September, with the project funding available to the cities the following July.

The cities would not lose any time or funding in waiting until next September because the funding would not be available until July 2025. Then, following COG approval in September 2024, Metro Board would approve the allocations and projects at the January 2025 meeting. Metro is hoping a shorter lead-time will mean less project funding adjustments in the future. Metro struggles if they must continue to amend and revise Funding Agreements for our city projects. In addition, by programming the funds in September 2024 for fiscal year 25/26, it will allow additional time to review the final design engineering, construction estimates and schedule for the Smart Cities Regional Fiber Network and for Malibu to decide if it wants to be part of the fiber project. To date, we are using rough estimates for the project and the design engineering will provide a construction estimate. The COG is currently anticipating a 2–3-year construction period.

I also spoke with Metro about utilizing existing Measure M funds for the Regional Smart Cities Fiber Network that extends through Hidden Hills. The city is anticipating construction early next year of its section of the fiber backbone, in conjunction with their city-wide fiber project. Measure M funds will only go toward the fiber backbone. That said, by approving \$1.5 million in the COG's Measure M Project List for the current fiscal year for the backbone, Hidden Hills will not have to wait 4-5 years to be reimbursed for the project costs.

I also spoke with Metro about programming \$5 million of the COG's Measure M allocation in 24/25, which would allow the COG to begin construction of the Regional Smart Cities Fiber Network a year earlier than planned.

The following are the above-described allocations:

2023/2024

 \$1.5 million to Hidden Hills for Regional Smart Cities Fiber Network backbone through the city.

2024/2025

\$5 million for Regional Smart Cities Fiber Network construction.

2025/2026

\$5 million for Regional Smart Cities Fiber Network construction.

I want to stress that waiting a year to program other project funding, the COG cities will not lose any funding or time. The COG will merely program future Measure M funds closer to the date the funds become available. e.g., The COG would approve the funding allocations in September and the funding become available to the cities roughly ten months later.

OVERVIEW

The purpose of this report is to provide the Governing Board with project funding recommendations for the 2023-2024 COG/LA County Homeless Contract.

RECOMMENDATION

Approve the 2023-2024 Homeless Contract with Los Angeles County which includes County grant funding for Regional Homelessness Coordination and Cities Innovation Fund and authorize the President to sign said contract.

BACKGROUND

The County makes an annual investment of Measure H funding to all the COGs for Regional Homelessness Coordination. The County grants are intended to facilitate a regional approach in preventing and combatting homelessness in Los Angeles County. The 2023-2024 Homeless Contract continues the COG's priorities as recommended by the COG's Homeless Working Group and confirmed by the Governing Board, as follows:

- Funding a full-time outreach coordinator.
- Funding part-time administrative support to assist the Executive Director.
- Providing direct client assistance to unhoused individuals.
- Reserving 4 beds at The People Concern for unhoused individuals that TPC is working with, in Malibu.
